

On the Question ; Shall Ordinance 91 pass ?

Badger, Helm, Hofman, McMullen, Orlander and Thoday voted AYE.

SHALL The Emergency Clause pass? Badger, Helm, Hofman McMullen Orlander and Thoday, Yes.

There being no objections the Mayor stated the Title would stand. and it was so ordered.

It was moved by Councilman Helm seconded by McMullen, that the Clerk be instructed to cast the unanimous ballot of the Council for Dr. J. A. Baughman as Health Officer. All Councilmen voting in the affirmative, the Clerk cast the ballot and declared J. A. Baughman elected as Health Officer Town of Seward.

It was moved by Councilman Orlander, seconded by Hofman that the Clerk cast the unanimous vote of the council for A. E. Rucker as Municipal Attorney. All councilmen voting in the affirmative. The Clerk cast the ballot, and declared A. E. Rucker elected as Municipal Attorney.

The Mayor Appointed Councilmen McMullen and Hofman, Tellers, and declared the council would proceed to ballot on the positions of Fire Chief and Chief of Police.

The Tellers reported six ballots cast as follows.

Robert Guest 6. Mr. Guest was declared elected to the position of Fire Chief and Chief of Police of the Town of Seward, instructed to take oath of Office.

It was moved by Hofman seconded by McMullen, that J.P. Hannon, be reappointed, City Clerk, Magistrate and Assessor.

All Councilmen voting in the affirmative.

It was moved by Councilman Hofman seconded Badger that the unanimous vote of the Council be cast for H. S. Balderston as Treasurer.

All Councilman voting in the affirmative, and the ballot was cast.

A Communication from School Board referred to the School Committee, asked for the loan of funds to cover period until remittance could be received.

School Committee reported necessity of arranging finances as council without funds with which to comply with their wishes?

City Attorney, reported impossibility of obtaining deeds to Anderson and Crawford lots, and that certain persons owning lots in the area desired for the Jesse Lee could not be located.

Mr. Jessen, representing the Seward Athletic Club addressed the Council in an effort of obtaining a continuation of the rental for the Gymnasium being used by the School Children. he was requested to present the facts in writing with a bill for the amount due.

Councilmen Helm and Thoday, Street Committee reported on the work on Streets, the expending of the funds allowed and requested further funds to carry on the work. For the work on Adams street \$300.00 was required. A Motion was made by McMullen seconded by Badger that this amount be allowed.

Upon calling the roll, Councilmen Badger, Helm, Hofman McMullen, Orlander and Thoday voted Aye and it was authorized.
